RM ASSESSOR**

1. Make sure that you have accessed and completed the relevant training packages for on-screen marking: *RM assessor Online Training*; *OCR Essential Guide to Marking*.
2. Make sure that you have read and understood the mark scheme and the question paper for this unit. These are posted on the RM Cambridge Assessment Support Portal <http://www.rm.com/support/ca>

MARKING

1. Mark strictly to the mark scheme.
2. Marks awarded must relate directly to the marking criteria.
3. The schedule of dates is very important. It is essential that you meet the RM 50% and 100% deadlines. If you experience problems, you must contact your Team Leader (Supervisor) without delay.

5. **Crossed Out Responses**
Where a candidate has crossed out a response and provided a clear alternative then the crossed out response is not marked. Where no alternative response has been provided, examiners may give candidates the benefit of the doubt and mark the crossed out response where legible.

Rubric Error Responses – Optional Questions

Where candidates have a choice of question across a whole paper or a whole section and have provided more answers than required, then all responses are marked and the highest mark allowable within the rubric is given. Enter a mark for each question answered into RM assessor, which will select the highest mark from those awarded. (*The underlying assumption is that the candidate has penalised themselves by attempting more questions than necessary in the time allowed.*)

Contradictory Responses

When a candidate provides contradictory responses, then no mark should be awarded, even if one of the answers is correct.

Short Answer Questions (requiring only a list by way of a response, usually worth only **one mark per response**)

Where candidates are required to provide a set number of short answer responses then only the set number of responses should be marked. The response space should be marked from left to right on each line and then line by line until the required number of responses have been considered. The remaining responses should not then be marked. Examiners will have to apply judgement as to whether a 'second response' on a line is a development of the 'first response', rather than a separate, discrete response. *(The underlying assumption is that the candidate is attempting to hedge their bets and therefore getting undue benefit rather than engaging with the question and giving the most relevant/correct responses.)*

Short Answer Questions (requiring a more developed response, worth **two or more marks**)

If the candidates are required to provide a description of, say, three items or factors and four items or factors are provided, then mark on a similar basis – that is downwards (as it is unlikely in this situation that a candidate will provide more than one response in each section of the response space.)

Longer Answer Questions (requiring a developed response)

Where candidates have provided two (or more) responses to a medium or high tariff question which only required a single (developed) response and not crossed out the first response, then only the first response should be marked. Examiners will need to apply professional judgement as to whether the second (or a subsequent) response is a 'new start' or simply a poorly expressed continuation of the first response.

6. Always check the additional pages (and additional objects if present) at the end of the response in case any answers have been continued there. If the candidate has continued an answer there then add a tick to confirm that the work has been seen.

7. Award No Response (NR) if:

- there is nothing written in the answer space.

Award Zero '0' if:

- anything is written in the answer space and is not worthy of credit (this includes text and symbols).

Team Leaders must confirm the correct use of the NR button with their markers before live marking commences and should check this when reviewing scripts

8. The RM **comments box** is used by your Team Leader to explain the marking of the practice responses. Please refer to these comments when checking your practice responses. **Do not use the comments box for any other reason.**

If you have any questions or comments for your Team Leader, use the telephone, email or the RM messaging system.

This Mark Scheme is a working document; it is not exhaustive; it does not provide 'correct' answers. The Mark Scheme can only provide 'best guesses' about how the question will work out, and it is subject to revision after we have looked at a wide range of scripts.

The Examiners' Standardisation Meeting will ensure that the Mark Scheme covers the range of candidates' responses to the questions, and that all Examiners understand and apply the Mark Scheme in the same way. The Mark Scheme will be discussed and amended at the meeting, and administrative procedures will be confirmed. Co-ordination scripts will be issued at the meeting to exemplify aspects of candidates' responses and achievements; the co-ordination scripts then become part of this Mark Scheme.

Before the Standardisation Meeting, you should read and mark in pencil a number of scripts, in order to gain an impression of the range of responses and achievement that may be expected.

In your marking, you will encounter valid responses which are not covered by the Mark Scheme: these responses must be credited. You will

encounter answers which fall outside the 'target range' of Level of Response Bands for the paper which you are marking. Please mark these answers according to the marking criteria.

Please read carefully all the scripts in your allocation and make every effort to look positively for achievement throughout the ability range. Always be prepared to use the full range of marks.

INFORMATION AND INSTRUCTIONS FOR EXAMINERS

- 1 The co-ordination scripts provide you with *examples* of the standard of each band. The marks awarded for these scripts will have been agreed by the Team Leaders and will be discussed fully at the Examiners' Co-ordination Meeting.
- 2 The specific task-related notes on each question will help you to understand how the band descriptors may be applied. However, these comments do not constitute the mark scheme. They are some thoughts on what was in the setter's mind when the question was formulated. It is hoped that candidates will respond to questions in a variety of ways and will give original and at times unexpected interpretations of texts. Rigid demands for 'what must be a good answer' would lead to a distorted assessment.
- 3 Candidates' answers must be relevant to the question. Beware of prepared answers that do not show the candidate's thought and which have not been adapted to the thrust of the question. Beware also of answers where candidates attempt to reproduce interpretations and concepts that they have been taught but have only partially understood.
- 4 Candidates' answers should demonstrate knowledge and understanding of the texts. This knowledge will be shown in the range and detail of their references to the text. Re-telling sections of the text without commentary is of little or no value.

INSTRUCTIONS TO EXAMINERS:**A INDIVIDUAL ANSWERS**

- 1 The indicative content indicates the expected parameters for candidates' answers, but be prepared to recognise and credit unexpected approaches where they show relevance.
- 2 Using 'best-fit', decide first which set of Level of Response Band Descriptors best describes the overall quality of the answer. Once the band is located, adjust the mark concentrating on features of the answer which make it stronger or weaker following the guidelines for refinement.
 - **Highest mark:** If clear evidence of all the qualities in the band descriptors is shown, the HIGHEST Mark should be awarded.
 - **Lowest mark:** If the answer shows the candidate to be borderline (i.e. they have achieved all the qualities of the bands below and show limited evidence of meeting the criteria of the band in question) the LOWEST mark should be awarded.
 - **Middle mark:** This mark should be used for candidates who are secure in the band. They are not 'borderline' but they have only achieved some of the qualities in the band descriptors.
- 3 Be prepared to use the full range of marks. Do not reserve (e.g.) high Level 6 marks 'in case' something turns up of a quality you have not yet seen. If an answer gives clear evidence of the qualities described in the band descriptors, reward appropriately.

Question 2

Both writers describe how they helped other people. What are the similarities between the people they helped? Draw on evidence from both texts to support your answer. (6 marks)

AO1iii: Select and synthesise evidence from different texts.

Where the candidate's answer consistently meets the criteria, the higher mark should be awarded.

Level 3 (5–6 marks)	A detailed response which shows a secure ability to synthesise appropriate ideas and evidence from both texts, showing perceptive understanding of the similarities between the people they helped , including conceptual ideas.
Level 2 (3–4 marks)	A response which shows some ability to make connections between ideas and evidence from both texts, showing clear awareness of the similarities between the people they helped . The ideas and evidence selected may not be equal across both texts.
Level 1 (1–2 marks)	A response which shows limited ability to select and make connections between evidence from both texts, showing little awareness of the similarities between the people they helped . The evidence selected is likely to focus on more obvious, surface features of the texts and may be imbalanced across the texts.
0 marks	No response or no response worthy of credit.

Question 2 Guidance

Give credit for answers that synthesise evidence from both texts. Higher level responses will draw together and synthesise perceptive ideas, using appropriate evidence from both texts. Lower-level responses will make straightforward connections between points and use some relevant evidence. Give credit for the quality of the response and the skill shown in the ability to synthesise appropriate ideas and evidence. Higher level responses will draw on conceptual ideas whereas lower-level responses will select and comment on more obvious features.

Candidates may refer to some of the following points:

- The people are ill – Text 1 – some of his men were dying – Text 2 – her face looks concave and her teeth are chattering
- The people live in poor conditions – Text 1 - in dirty hammocks – Text 2 - at home with no heating
- The people are grateful – Text 1 - nothing better to give me than their thanks – Text 2 - You're so kind
- The people need practical help – Text 1 - every effort was made to ventilate the place – Text 2 - can I get you a cup of tea and a sandwich
- They are suffering or in pain – Text 1 – groans and agony - Text 2 – chest pain or bruises
- They are both cold – Text 1 – lighted a fire – Text 2 – temperature ... dangerously low
- Physical response – Text 1 - they screamed and groaned – Text 2 shivered and chatteredNB
- Do not accept 'weak' as a link.

Question 3

Look at lines 10-31. Explore how Christie Watson uses language and structure to present Betty. Support your ideas by using relevant subject terminology. (12 marks)

AO2: Explain, comment on and analyse how writers use language and structure to achieve effects and influence readers, using relevant subject terminology to support their views. Where the candidate's answer consistently meets the criteria, the higher mark should be awarded.	
Level 6 (11–12 marks)	A skilled analysis which demonstrates a sophisticated appreciation of how the writer has used language and structure to achieve effects and influence the reader. Candidates' analysis of both language and structure is consistent and detailed. Precisely selected and integrated subject terminology deployed to enhance the response.
Level 5 (9–10 marks)	An analysis which demonstrates a perceptive understanding of how the writer has used language and structure to achieve effects and influence the reader. Candidates' analysis of both language and structure is reasonably detailed and balanced. Well-chosen subject terminology integrated into explanations.
Level 4 (7–8 marks)	A developed explanation which shows a secure understanding of how the writer has used language and structure to achieve effects and influence the reader. Candidates comment on the effects of both language and structure, but the explanation may not be entirely balanced. Relevant terminology should be used to develop ideas.
Level 3 (5–6 marks)	A clear explanation which shows a general understanding of how the writer has used language and structure to achieve effects and influence the reader. Candidates refer to language and structure but may not give a full explanation of the effects of both. Some use of relevant subject terminology to support ideas.
Level 2 (3–4 marks)	A straightforward commentary which shows some understanding of how the writer has used language and structure to achieve effects and influence the reader. Candidates are likely to refer more fully to either language or structure and note some features without explaining the effects. Some use of subject terminology, though it may not always be relevant.
Level 1 (1–2 marks)	A descriptive response which shows limited awareness of how the writer has used language and structure to achieve effects and influence the reader. Little or no use of subject terminology.
0 marks	No response or no response worthy of credit.

Question 3 Guidance

Give credit for answers that link aspects of language and structure with **how Watson presents Betty**, supported by close and relevant reference to the text. Give credit for accurate use of relevant terminology integrated into responses, which shows a precise understanding of features and their effect in this text. Candidates must refer to the use of language and structure in their response. A response which does not achieve a reasonable balance between references to language and to structure cannot achieve the higher levels, as indicated in the level descriptors.

Candidates **may** refer to **some** of the following points:

- Thank you, love - affectionate term of address.
- nuisance - repeated but negated by Christie to show contrast
- Betty smiles. simple sentence for emphasis
- They don't pay you girls enough - the word girls suggests a kind of authority or wisdom
- encloses - the verb makes Betty seem safe or like a passive victim
- like a hot-air balloon - the simile makes the experience seem more pleasant
- proper material versus parachute silk - contrast reinforced by alliteration
- she wolfs down her dry sandwich the metaphor conveys her hungry – emphasized by alliteration
- her paper-thin hand - metaphor emphasizes her frailty
- crumpled - metaphor suggests her age
- a frail old woman alone on a hospital trolley, and instead see a young woman in a dress made from parachute silk – contrast of youth and age
- dancing – progressive merges past and present

Question 4

'In both texts the writers help because they sympathise with their patients.' How far do you agree with this statement? In your answer you should: discuss what makes the writers sympathise with their patients; explain how far you agree that the writers sympathise with their patients; compare the ways the texts present the writers' sympathy for their patients. Support your response with quotations from Text 1 and Text 2. (18 marks) *SKILLS:* Mark the response out of 12 marks (AO4) and out of 6 marks (AO3) using the two sets of level descriptors below; add the two marks together to award a total mark out of 18. Where the candidate's answer consistently meets the criteria, the higher mark should be awarded.

Question 4 Guidance

This question assesses AO4 and AO3. AO4 is worth 12 marks and AO3 is worth 6 marks. The first two bullet points of the question prompt candidates to evaluate the text (AO4) and the third bullet point prompts candidates to compare the texts (AO3). Candidates may construct their answer in response to the bullet points in combination and integrate their evaluative and comparative commentary throughout; this is a valid approach which may achieve the highest levels for AO4 and AO3. Give credit for critical evaluation of 'how far' the candidate agrees with the statement that the **writers are impressed by the inventors**. Accept all valid evaluations which are supported by appropriate, integrated references to both texts. For example, some candidates may consider one writer to be more impressed than the other.

Candidates may compare these points in response to AO3:

Text 1 shows less sympathy than Text 2:

- those who could afford to pay for my services did so handsomely
- nothing could ... induce them to bear their sufferings like men
- so painful to hear and to witness
- no screens could shut out their awful groans

Text 2 shows more sympathy than Text 1:

- I tuck the blanket around her, careful to move slowly
- I smile at her and take her hand, giving it a gentle squeeze
- I would love to have cut Betty a thick slice of fresh bread
- I stand listening to her, holding her paper-thin hand
- if I listen hard enough, I stop seeing a frail old woman

Candidates may evaluate these ideas in response to AO4:

Text 1 shows some sympathy:

- nothing better to give me than their thanks.
- he promised me a large remuneration
- its wretched inmates
- the groans of the sufferers
- my poor patients

Text 2 shows complete sympathy:

- I smile at her and take her hand, giving it a gentle squeeze
- can I get you a cup of tea and a sandwich
- would love to have cut Betty a thick slice of fresh bread
- holding her paper-thin hand
- But I stay another minute and ... listen
- stop seeing a frail old woman ... and instead see a young woman
